President's Report

I am pleased to report on the activities of the Avon Hockey Club in 2020, being the 20th season for the club.

2020 got off to a delayed and inauspicious start with the effects of the national Covid-19 lockdown and the many uncertainties for sports administration and indeed individuals and families for the immediate future. There was some early conjecture that the season may be abandoned before it started, but as new Covid alert level rules developed and were released, a path forward via Hockey NZ and CHA was established. In the end we were able to enjoy a near full club season with only the representative season across many age groups being curtailed.

The Junior club in partnership with St Michael's Church School was adversely affected in playing numbers as families have taken time out to assess their circumstances, and there was a bubble of year 8 players in 2019 that had moved on. We dropped from 12 teams to 7 with player numbers falling from 114 junior club members to 70. Michael Graveston who again performed a fantastic job in organising and resourcing the junior teams perhaps enjoyed the reset and really delivered a quality season for all those who did participate. Next season will bring with it changes with the dropping of 11-a-side hockey from the Junior section with focus on participation and players getting more time on the ball. Thank you to all the parents for their support throughout the season and the enthusiastic group of great young coaches that run the practices and game time for the teams, you were all a credit to the Avon Hockey Club in 2020. We can always use more support in this area so if there are any members or parents keen to be involved with coaching or managing a junior side please let Michael know.

In the Senior section our club entered 14 teams, as we had last season, maintaining our presence in every grade across both men's and women's competitions. The fact that we could muster the same number of teams was a good reflection on our goal of being the Club of Choice, although our total player numbers were down from 217 to 190.

Our CPL teams again performed strongly in the top competition in town. Both the men's and women's teams made it to the semi-finals to the delight of their respective sponsors, helloWorld Fendalton and Hair Art & Beauty. Unfortunately, neither side could meet the challenge on the day and make it to the big show but certainly the progression is evident and 2021 will be yet another exciting journey to follow them on. There were two Avon teams to triumph and win their grades in 2020, threepeat winners the Grass men and the up-and-coming youth men's Orbit Protect Platinum Gold team dominating their Platinum grade. Congratulations to both of our champion sides, fantastic achievements.

CHA introduced new community awards to fill the representative void and I am really pleased to say Avon was well represented in finalist nominations across the categories. Community Coach; Matt Walcott, Community Team; CPL Men, and for Service to Community; Kurt Gurden. The Club is immensely proud of the CPL Men and Kurt Gurden for being inaugural winners of their respective awards and it is great recognition of how their actions and conduct are perceived by the wider Canterbury Hockey Community.

I would like to thank the committee who worked hard to enable the smooth running of the 2020 season in what can only be described as challenging and changing times. A special mention goes to Ari Barrow, Men's Club Captain and CPL Men's Captain, who was awarded the Ross Gillespie Trophy in 2020 for his outstanding contribution to the Club. Ari was recipient of this trophy for his adoption of

our Club of Choice goal, having gathered great mentors in Pete Darling, Craig Armitage and Mick Piggott to the men's squad and developing a younger Div 1 side as a talent generator to feed the CPL side. Ari has lifted the standards that the men demonstrate to the hockey community evidenced by the CPL Men winning the Community Team Award. We have a very capable group of volunteers that make this club function. Robin Cox with the secretarial work had an exceptionally busy season dealing with all the additional Covid correspondence, registrations, and CHA matters throughout the season. A few of us senior committee members are ready to make way for fresh committee talent and are always on the lookout for more help. Please commit to assisting wherever possible or just make things as easy as possible for those trying to get a job done. We often need people to step up as coaches or managers as our club grows so please come forward if this is something that may interest you.

With the Covid situation at the beginning of the season we were prepared to invest some cash reserves in just making the season happen, but again under the guidance of Kurt Gurden as Treasurer we made a small surplus and in fact grew our cash balance. A huge thank you to our sponsors and the charitable trusts that do support us, and we should look to support them in return throughout the year. Hair Art & Beauty, helloWorld Fendalton, Robbies Riccarton, and Orbit Protect.

Issy Thomson ran two more successful quiz nights despite alert level rules, and our annual prize giving dinner has become so popular we have had to split the awards into two events. 2020 was a season that came with many challenges but equally we had a lot of enjoyment through great teamwork and competitive spirit exhibited by members throughout their respective teams and competitions. Thank you all for your good conduct on the field, and our Avon supporters conduct off the field. Compete hard but play fair, be restrained in any comments to officials and be respectful towards other players. Winners are grinners, but never lose sight of why we play the game. Hockey is a fantastic sport, fast, skilful and exciting, and fun to play win or lose.

Thank you all for your contributions to Avon Hockey Club life in 2020 and I look forward to an even brighter season in 2021.

Treasurer's Report

The 2020 hockey season was certainly one like no other. As we entered lockdown, the season became a large unknown and this created significant uncertainty from a financial perspective. As is normal at the start of each year, we put in our applications for various gaming trust grants. We put in for turf and match fees, costs to assist our coaches, and new uniform purchases. As lockdown started, all grant applications were cancelled by the respective funders. This was especially unfortunate, as Lion Foundation had just approved a grant of \$10k, which they did not even up paying.

As lockdown progressed, it was difficult to complete any meaningful financial planning for the season without any idea of the costs, the funding available, and possible sponsorship opportunities. I attended a webinar regarding community funding which suggested gaming funding would drop by 40%. However, as lockdown progressed to Level 3 and into Level 2, there was light at the end of the tunnel. Sport Canterbury opened up their first Community Resilience Fund, and on application, we received \$1k towards costs. Two months later, they opened up round two of funding and the fund was able to generously grant us \$7,830. Pub Charity also came to the party for us with a \$5k grant for turf and match fees. NZCT also provided a grant to assist our top level, and longest serving coaches with assistance to their costs. We are very appreciative of all funders who supported us during the season.

Further to this, one of most dedicated life members gave the club a large donation which the club used to assist some of our most struggling families with their subs. We are forever thank our long-term sponsors to the club, especially Hair, Art and Beauty, helloWorld Fendalton, Robbies Riccarton and Orbit Protect. This year was hard for your sponsors, especially our CPL sponsors, so the club decided it was best to support them like they have done for us for so many years, so it was decided no fees would be charged for sponsorship this year. We were saddened to learn that helloWorld Fendalton had decided to close its doors at the end of 2020 due to challenges faced by the travel industry at the moment. I do wish to give my thanks to Bridget and Glenn Hanrahan for their support since 2018 of our CPL Men's team.

From a subs perspective, we chose to bill our pre-lockdown subs amount, however giving our players the option of taking a discount for the portion of the season missed due to lockdown. I would estimate that a third of our members still chose to support the club by paying the full season subs amount. I would like to say a special thanks to these members for your generosity in the uncertain season we found ourself in. But I also wish to thank all members who paid their subs on time as this makes my job much easier.

With a combination of all of the above, we did manage to increase our cash position over the year which managed to keep the club in a safe financial predicament moving into the next season. We achieved significant efficiencies in our junior delivery with the use of the new Shirley Boys High School turf, which was only a tenth of the cost of their old one and much larger.

As always, I want to thank the support I have from my fellow committee who work tirelessly for our club. We are looking forward to hopefully normal 2021 hockey season!

Avon Hockey Club Incorporated is comprised of a committee of 13 voluntary persons, including key positions of President, Vice-President, Secretary, Treasurer, Men's/Women's/Junior Club Captains, with all other positions being general committee positions. The club operates with the assistance of volunteer coaches and managers.

The Club operates under two divisions, being senior and junior club. The senior club operates under the oversight of the committee and offers hockey in both men's and women's grades as well as youth grade. The junior division also acts under the oversight of the committee and junior club captain. Hockey is offered to all junior players. The junior division operates in partnership with St. Michael's Church School.

Main Sources of Entity's Cash and Resources

Avon Hockey Club Incorporated's main sources of cash are from the receipt of player subscriptions, grant funding from local organisations, sponsorship, fundraising – primarily from pub quizzes and junior chocolate fundraisers, and other sundry sources.

Entity's Reliance on Volunteers and Donated Goods or Services

Avon Hockey Club Incorporated is reliant on volunteers to operate the club and its teams. The Club currently employs no persons to assist with its operation. The Club receives very few donated goods from other persons or parties.

Basis of Preparation
